Submission Guidelines

Eligibility:

The GOABC "Artist of the Year" program is open to any artist who supports the mission of GOABC:

The Guide Outfitters Association of British Columbia is committed to a strong and stable guide outfitting industry that offers the highest quality wilderness experience and professional standards. The Association advocates the promotion and practice of wise conservation management and use of natural resources.

The Guide Outfitters Association of British Columbia continually pursues co-operation and cordial relations with those who use and enjoy British Columbia's natural heritage. The Association seeks to improve laws governing or affecting the guiding and tourism industry in British Columbia. The Association is committed to maintaining the profile of guide outfitting in a positive and professional manner which will benefit the industry and surrounding communities.

All artists must agree to abide by the guidelines listed below.

Artwork Criteria:

MINIATURE ART – **MAXIMUM SIZE: 144 square inches (12 x 12 or 11 x 13 or 10 x 14.5)**
Metric equivalent: 929 square centimeters (30.5 x 30.5 or 28 x 33 or 25 x 37)
"Over size" - not eligible for competition

- ~ All artwork must be two-dimensional and not previously reproduced.
- ~ The artwork should depict subjects within the wildlife and nature-related fields of art. This may include the sports of hunting and fishing.
- ~ There is no restriction as to the use of medium.

Artwork Selection:

- ~ The artwork will be judged by secret ballot by all delegates attending GOABC's 2009 Annual Convention in Victoria, March 19th – 20th, 2010.
- ~ All originals are considered donated and will be auctioned off at the convention with a 50% split going to the artist.

Submission Procedures:

- ~ Interested artists may submit **ONE ONLY** original.
- ~ The GOABC Arts Committee will have final authority as to acceptability of any/all artwork.
- ~ **DEADLINE:** All entry forms must be sent to Brenda Nelson by **Feb. 19, 2010**. Fax 250-842-6350, lovebroslee@bulkley.net
- ~ ALSO please include a high resolution digital photo of the artwork (against a black background) emailed to Brian Glaicar at monashee@lincsat.com by **February 19, 2010**. We want to show your art work on the big screen during auction.
- ~ AND all art must be **accompanied by a completed copy** of the submission form (see attached) and a **promotional photo** of you and delivered to our **Surrey** office located at 103 19140 28th Avenue, Surrey, BC V3S 6M3.
- ~ The piece of art must be **received at our Surrey office by March 5, 2010**, unless you plan to bring it to the convention in person.
- ~ All entrants are responsible for their own insurance, shipping, and framing.
- ****Please help insure the safe shipping of your artwork to the purchaser by **providing proper packaging/crating**.

Rewards:

- ~ The first, second, and third place winners will receive recognition and have a photo of their entry published in the Mountain Hunter magazine, circulation of four to five thousand sportsmen and potential art collectors.
- ~ Every entrant will receive 50% of the selling price at auction.
